AD IN CHARGE: D.C. Everest

ANNUAL MEETING DATE: The annual meeting will take place at the DC Everest IMC on the Monday prior to the start of Sectionals- 6:30pm (Week #17). If there is a need to change this meeting, the AD in charge will notify all coaches and ADs.

PARTICIPATING TEAMS: DC Everest, Marshfield, Merrill, Stevens Point, Wausau East, Wausau West, Wisconsin Rapids

SCHEDULE FORMAT: The volleyball schedule shall be a double round; one round a dual schedule, the other a two day Valley Conference Tournament plus one extra dual.(11/07)
Any changes in the conference schedule date must be my mutual agreement of schools.

TIME(S) Non-varsity contests precede varsity matches. The non-varsity meet will start at 5:30 and varsity no earlier than 7:00 p.m.
WVC Saturday multis scheduled start time at all sites is 9:00am. (12/03)

SITE/MATCH DETAILS: For Dual meets- Varsity- Winning 3 of 5 wins match, 4th or 5th games played only when needed to determine the winner.
Junior varsity and JV2 shall play two (2) rally scored games to 25 points and a 3rd set to 15pts with no cap. (12/23)
Teams shall keep the same benches during WVC matches at all levels.(12/23)

GAME RESULTS: The home team is responsible to report game results to local media and Channels 7, 9 and 12 immediately following the game. This is mandatory for conference games but should be done for non-conference games as well.

OFFICIALS: Officials must be registered WIAA officials and will be contracted by the conference commissioner. The commissioner should avoid using hometown officials for initial game assignments (12/02) or assigning the same officials for all of a school's home matches. (11/07). The commissioner hires officials for the approved schedule as of the prior year April 15.

The host school shall schedule the use of adult line judges for varsity WVC matches. (12/15)

ROSTERS: Each coach/school is to send out a team roster to all W.V.C. schools or post their current roster in rSchool.
A note showing which game will be Parent's Night would be appreciated.

TOURNAMENT DETAILS: WVC Saturday Multi-Meet Host: (12/09)

The host school is responsible for providing a meet manager.
Schedule of 2 to 3 matches per team at each meet. (12/08)
Results board will be posted.
Winning 3 of 5 wins match.
A break after round #2 is 40 minutes. (12/09)

CONFERENCE CHAMPIONSHIP: Each school to be eligible for championship consideration must play the schedule as adopted. Conference Champions shall be determined by the final WVC win-loss record.

ALL CONFERENCE SELECTION All-Conference selections will be made in the following manner:
Nominations for ALL (except VFA football) sports are due one week prior to the respective coaches meeting. The commissioner will then send out a composite ballot containing all nominees.
At the meeting each coach will discuss their own nominees; may delete but not add players.
Coaches will fill out a ballot by selecting 7 players on the 1st and 2nd teams after all discussions are complete. A coach may not vote for their own nominees. 10/11
The AD or group facilitator will read aloud each school's 1st and 2nd team selections openly.
Ties, if they exist, for the 1st and 2nd team broken by the greater number of 1st Place votes received. If a tie still remains, additional medals will be awarded. Unbroken ties for 1st team will appropriately reduce the number of 2nd Team selections.
Any nominee receiving any votes that is not on 1st team or 2nd team, shall be awarded Honorable Mention. If a school did not receive any all-conference selections they may select an HM player from their list of nominees. (8/23)
Any individual conference award is subject to the school's discretion.

PLAYER/COACH OF THE YEAR: A Player and/or Coach of the Year award may be chosen by the coaches using any agreed upon criteria. The Player of the Year must be a 1st Team selection.

FINANCIAL RESPONSIBILITY OF WVC: Awards- Team trophy (ies), All-Conference medals (1st and 2nd Team) and All-Conference Certificates (1st/2nd team plus Honorable Mention).

PERTINENT INFO: W.I.A.A. rules and regulations will govern competition. (See W.I.A.A. Handbook)
